



OFFICIAL CALL

2022 Party Canvass of the 10th Congressional District Republican Committee

As Chairman of the Tenth Congressional District of the Republican Party of Virginia, and pursuant to the Plan of Organization and as recommended and directed by the District Committee, I, Geary Higgins, do hereby issue this call for a Party Canvass to be held from **9 a.m. until 4 p.m. on Saturday, May 21, 2022**, for the purpose of nominating a Republican candidate for Member, U.S. House of Representatives, to be voted for in the November 8, 2022 General Election.

In-person absentee voting will be conducted on **Thursday, May 12, 2022** at **The Middleburg Barn, 23320 Foxchase Farm Lane, Middleburg, VA 20117 (or alternate location)** from **4 p.m. to 8 p.m.** Allowable reasons for in-person absentee voting are enumerated below.

Balloting Stations by Locality

In jurisdictions with more than one balloting station, voters are permitted to vote only at the balloting station assigned to the precinct in which they are registered.

FAIRFAX COUNTY

Clifton Town Hall, 12641 Chapel Road, Clifton, VA 20124 (or alternate location) for registered voters in the following (based upon Districts and Precincts current to the date of this call and **not** reflecting 2022 redistricted lines):

- **Precincts** 315, 803, 851 (10th Congressional District portion), 915 (10th Congressional District portion), 921 (10th Congressional District portion), and 926 (10th Congressional District portion)

FAUQUIER COUNTY registered voters in all precincts vote at **Fauquier High School, 705 Waterloo Road, Warrenton, VA 20186 (or alternate location)**.

LOUDOUN COUNTY

RAPPAHANNOCK COUNTY registered voters in all precincts vote at **Rappahannock County Elementary School, 34 Schoolhouse Road, Washington, VA 22747 (or alternate location).**

Qualifications for Participation

All legal and qualified voters of the Tenth Congressional District under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, this party canvasses, conventions or primaries encompassing their respective election districts.

In addition to the foregoing, to be in accord with the principles of the Republican Party, a person otherwise qualified hereunder shall not have participated in Virginia in the nomination process of a party other than the Republican Party in the last five years. A single exception shall be approved for a voter that renounces affiliation with any other party in writing, and who expresses in writing that he or she is in accord with the principles of the Republican Party and intends to support the nominees of the Republican Party in the future.

Any voter who, subsequent to making a statement of intent, publicly supports a candidate in opposition to a Republican nominee is not qualified to participate as a member of the Republican Party of Virginia in its mass meetings, party canvasses, conventions, or primaries for a period of four years.

Balloting

Balloting will begin at 9:00 a.m. and will end at 4:00 p.m., except that anyone in the registration line at 4:00 p.m. may continue the registration process.

In order to receive a ballot, the voter must present a valid, non-expired photo identification issued by the Commonwealth of Virginia, one of its political subdivisions, the United States government, or a United States college or university.

A statement of intent, properly completed and signed by the voter or verbally affirmed, must be provided at the time of registration. No ballot will be given to any voter who has not signed and submitted this statement of intent or affirmed the statement of intent verbally.

No absentee voting, proxies, or provisional ballots are permitted with the exception of the following:

- In-person absentee voting will be conducted at **The Middleburg Barn (or alternate location) on May 12, 2022 from 4 p.m. to 8 p.m.**
 - Absentee voting requires an excuse; this is not to be confused with “early voting.”
 - Voters may participate in absentee voting for the following reasons that preclude them from taking part in the Canvass:
 - Active-duty military (see below)
 - Working/commuting to/from home during the full timeframe of voting on May 21, 2022
 - Out of County during the timeframe of voting on May 21, 2022
 - Personal business or vacation during the timeframe of voting on May 21,

- Religious belief or practice
 - Medical reasons (e.g., scheduled procedure)
- Active members of the U.S. Armed Forces may request an absentee ballot from **RJ Hall at militaryballot@vagop10.org by Saturday, April 16, 2022. Absentee ballots must be returned and received by mail by Friday, May 20, 2022 at 4 p.m. Postmarks shall not govern.**

No registration fees are required for voting in this party canvass.

Votes will be counted only for those candidates whose names appear on the official ballot in an order determined by lot. No write-in votes will be permitted.

The canvass shall nominate one candidate for Member, U.S. House of Representatives by majority vote determined, in the case that the nomination is sought by more than two candidates, otherwise qualified and properly filed, by ranked choice voting.

Candidate Filing Requirements

Any person seeking election as the Tenth District Republican Nominee for Member, U.S. House of Representatives must submit a completed and signed Official Filing Form, along with a **non-refundable filing fee of \$6,960.00** (six thousand, nine hundred and sixty dollars), paid by valid check or money order, not later than **5:00 p.m. on Wednesday, March 30, 2022**, to **Stacy Carey, Nominations Committee Chairman, 47752 Rafter Court, Sterling, Virginia 20165**. Actual receipt is required by mail or in-person. Postmarks will not govern. Incomplete or modified filing forms, and/or filing forms accompanied by an invalid check, will be returned, and the individual will be deemed to have not filed for candidacy. The Official Filing Form can be downloaded from the Republican Party of Virginia website, www.rpv.org.

If not more than one person properly files for candidacy and is determined to be qualified, then that person is deemed to be nominated and the canvass will not be held.

Committees

Chairmen of the Rules, Nominations, Credentials, Tellers, Security, and Logistics Committees are appointed by the Chairman of the Tenth Congressional District Republican Committee. These committee chairmen will appoint the members of their respective committees at their own discretion with representation of the majority of units on each. The committees will meet prior to the canvass on the call of their respective appointed chairmen.

The canvass will be governed by (giving precedence as listed): the Republican Party of Virginia Party Plan, the Call of the Canvass, and the Rules adopted by the Tenth Congressional District Republican Committee.

The nomination will be decided by the majority of the valid votes cast at all balloting stations as determined through ranked choice voting. The vote will not be weighted.
